# **PARENT CODE OF CONDUCT**

The McFarland Recreation and Park District has established a code of conduct for coaches, players, and parents. The code of conduct outlines all unacceptable behavior. Parents who violate the code of conduct may be removed from district facilities immediately and possibly suspended from attending future games or events and may force the suspension of their child from future games.

**THIS INCLUDES, BUT IS NOT LIMITED TO THE FOLLOWING:**

- 1. VERBAL ABUSE DIRECTED AT AN OFFICIAL, PLAYER, OR SPECTATOR.**
- 2. PHYSICAL ATTACK OR LAYING HANDS UPON, STRIKING, OR THREATENING AN OFFICIAL, PLAYER, OR SPECTATOR.**
- 3. USING UNNECESSARY ROUGH TACTICS IN PRACTICE OR GAMES TOWARDS ANOTHER PLAYER, OFFICIAL, OR SPECTATOR.**
- 4. SETTING FOOT ON THE FIELD/COURT WITHOUT REASONABLE CAUSE.**
- 5. BEING INTOXICATED AT ANY OF OUR FACILITIES.**
- 6. PROFANITY OR BELITTLING REMARKS TO PLAYERS, COACHES, OFFICIALS, OR SPECTATORS**
